





LIFETIME ACHIEVEMENT AWARD ZELMA LONG

ENOLOGIST, WINEMAKER, CONSULTANT AND AUTHOR FOR MORE THAN 50 YEARS



A prolific enologist, winemaker, consultant and author, Zelma Long is one of the forerunners of California wine and was the first woman to assume leadership of a Californian winery, Simi Winery in Sonoma County. She founded the American Vineyard Foundation to help finance research in enology and viticulture, as well as the American Viticulture and Enology Research Network (AVERN). Zelma was also the founding president of Alexander Valley Winegrowers and a founding member of the North Coast Viticultural Research Group.

Zelma has received numerous awards and accolades over the course of her career, including the James Beard Hall of Fame and James Beard Wine Professional of the Year. She was named California Wine Pioneer by Wine Spectator and inducted into the Culinary Institute of America's Vintner's Hall of Fame. In 2009 the American Society of Enology and Viticulture selected her for the ASEV Award of Merit.

She has also received the Outstanding Alumni Award from the University of California, Davis. Zelma has written and contributed to numerous books and publications focused on wine, winemaking and the science of growing grapes.

Zelma has been involved in winemaking and viticulture projects around the world for the past 50 years and serves as a mentor to aspiring viticulturalists and winemakers. In the course of her career, she has consulted in countries and regions as diverse as Israel, Germany, the Rhone Valley, the Pacific Northwest and South Africa. She established Zelphi Wines with her husband Dr. Phillip Freese and they have, over 25 years, founded and established as winemaking partner and winegrowing partner Vilafonté Wine Estate in South Africa, named Best Wine Producer in the International Wine and Spirits Competition in 2021.

ICON

MARIMAR TORRES FOUNDER & PRESIDENT MARIMAR ESTATE VINEYARDS & WINERY




Marimar Torres has been involved in the wine business all her life. Born in Barcelona, Spain, she is fluent in six languages and holds a degree in Business & Economics from the University of Barcelona. She is also a graduate of the Stanford Executive Program and studied enology and viticulture for a year at the University of California at Davis. Prior to her involvement in the California operation, Marimar traveled extensively promoting Torres wines, first in Spain as the company's export director and later in North America, when California became her home in 1975. At that time, shipments of Torres wines to the U.S. totaled 15,000 cases; ten years later they reached 150,000.

In 1986, Marimar began planting the Don Miguel Vineyard, a 56-acre property in a cool microclimate in the Green Valley of the Russian River Valley ideally suited to Chardonnay and Pinot Noir. Today the property encompasses 81 acres, planted with Chardonnay, Pinot Noir, and the Spanish varieties Albariño, Tempranillo and more recently, Godello. Also planted to Pinot Noir are 20 acres of a 180-acre property in West Sonoma County, between Freestone and Occidental. In 1992, a 15,000-case winery was built and the estate's first Pinot Noir was produced. Recently, her daughter, Cristina Torres, has taken over the day-to-day winery operations as General Manager while Marimar continues to be an enthusiastic ambassador for her unique wines and cookbooks, which highlight Spanish cuisine.



INNOVATOR GEORGE CHRISTIE

FOUNDER & CEO, WINE INDUSTRY NETWORK PARTNER, SAINI VINEYARDS



George Christie, a New Jersey native, settled in Sonoma County in 1991 and quickly realized that the wine industry was where he wanted to concentrate his efforts.

Since then, he has been involved in nearly every aspect of the industry, from winery management, vineyard operations and grower relations to distributor management and national marketing campaigns. George has held board positions with the Russian River Wine Road, Winegrowers of Dry Creek Valley, Sonoma County Vintners, Sonoma State Wine Business Institute, and WineAmerica.

In 2008, George and his wife Tami partnered with the Saini Family, fifth-generation Sonoma County grape growers, to create Saini Vineyards.

In 2009, Wine Industry Network (WIN) began as an online directory. It has evolved over the years into a leading B2B marketing and media company and primary business resource for the North American wine industry.

WIN works with over 600 industry vendors and produces the North Coast Wine Industry Expo (WIN Expo), the Wine Sales Symposium and educational webinars. The Sonoma County Barrel Auction is produced by Sonoma County Vintners, a nonprofit organization committed to promoting the wines and wineries of Sonoma County. Since 1946 the association has focused on building awareness of its diverse appellations and the resulting distinctive wines.

- These Terms and Conditions of Sale as amended by addendum or oral announcements during the sale constitute the entire Terms and Conditions of Seller with respect to the sale and purchase of wines listed herein. By bidding, the bidder agrees to be bound by these Terms and Conditions of Sale. No representative or employee of Seller shall have the right to waive or modify any of the Terms and Conditions set forth herein, except that the Seller's authorized representative may do so by general announcement at the Auction.
- 2. Admission to the Sonoma County Barrel Auction will be to licensed members of the trade and their guests, each of whom must be registered. All bidders must be licensed members of the wine trade who have registered as a bidder and received a numbered paddle. All participants must be at least 21 years of age, with valid identification. Sonoma County Vintners reserves the right to refuse admission to, or excuse attendance from, any or all Auction events.
- 3. The Auctioneer, John Curley Auctions is the agent for Sonoma County Vintners (SCV or Seller).
- 4. Neither Sonoma County Barrel Auction, nor SCV, nor John Curley Auctions (Auctioneer), assumes any risk, liability or responsibility for the authenticity, value or authorship of any property identified in this catalog.

Bidding and Sales

- Bidding in person at the Auction will be by numbered paddle issued to registered bidders only. A bid is entered by raising your numbered bid card and being acknowledged by the auctioneer. Absentee bidders will be represented by a proxy who will bid on their behalf. Bids, once made, may not be withdrawn. No bid shall be valid unless acknowledged by the Auctioneer. Bids will be accepted only from registered bidders. This includes absentee bids.
- 2. The starting bid for each lot will be at the discretion of the Auctioneer.
- 3. Bids will be made on the purchase price for the total lot. Cost of shipping, insurance and any applicable taxes are not included and are to be covered by the auction lot buyer.
- 4. Seller shall have the right to reject any bid at any time prior to the fall of the hammer.
- 5. The Auctioneer shall have the right to withdraw a lot or reject a bid in its discretion at any time prior to the fall of the hammer for the lot in question. Should a dispute arise between bidders, the Auctioneer shall have the right to resolve the dispute, re-offer the lot or withdraw the lot in question.
- 6. The Auctioneer is not responsible for errors in bidding by any participant. Please double check your catalog to ensure bidding on the correct items.
- 7. The highest bid of record for each lot when the bidding is closed will be recorded as the purchaser of the lot ("Purchaser"). In the event of any dispute between bidders, the Auctioneer shall have sole and final discretion either to determine the successful bidder or to re-offer and resell the article in dispute. If any dispute arises after the sale, Sonoma County Barrel Auction sale records shall be conclusive in all respects. Video recording of the auction will constitute the final record of the sale of all auction lots.
- 8. All sales are final. There are no refunds. Purchaser warrants that he/she will pay the full purchase price no later than May 31, 2024. Seller's sole liability for non-delivery shall be limited to refund of the purchase price.
- 9. All property is sold "as is" and neither Sonoma County Barrel Auction, SCV, nor John Curley Auctions (Auctioneer), makes any representations or warranties of any kind or nature, expressed or implied of any item. No statement in the catalog or made at the sale, or elsewhere, shall be deemed such a representation, warranty, or an assumption of liability. Prospective bidders, by so bidding, acknowledge that they have inspected the wines to their satisfaction and bid only as a result of their own inspection and opinion.
- 10. All wines sold herein are offered and sold subject to the provisions of the California Alcoholic Beverage Control Act and Federal Alcohol Administration Act, and the rules and regulations applicable thereto. Any offer or sale shall be governed by and interpreted under the laws of the State of California.

TERMS AND CONDITIONS OF SALE

Absentee Bidding

Prospective bidders are advised to attend the Auction, but proxy bidding is available for absentee bidders. You must be a registered bidder in order to have bids executed on your behalf. Please register at sonomawine.com/barrelauction and indicate that you are interested in proxy bidding.

Bids must be submitted to SCV prior to the Auction for execution at or below a specified price. Absentee bidders will be represented by a proxy who will bid on their behalf. The Auctioneer, Proxy Bidder, and SCV shall not be responsible for the failing to execute such bids or for errors relating to the execution of such bids. In the event that SCV has received absentee bids on a particular lot for identical amounts, and at Auction those bids are the highest bids for that lot, the lot shall be awarded to the person whose bid for that amount was received first.

Payment

Winning bidders will be invoiced directly following event. Payment for all purchases must be made in US Dollars by check, electronic funds transfer (EFT), Visa, MasterCard or American Express upon receipt of invoice. No sales tax will be charged, with proof of valid resale license. Invoices not paid in full by May 31, 2024 will accrue a finance charge of 1.5% per month (18% per annum) on any unpaid balances until paid in full. Purchaser agrees to pay all attorney's fees and costs associated with the collection of past due amounts. No lot will be released without proof of payment in full.

Delivery

All lots are FOB Sonoma County, California by SCV. Wines offered in this Auction do not include the barrel and will be bottled in specially labeled bottles. SCV will design and select the labels in its sole discretion with no input from the Purchaser. All wines will be bottled in 750ml format. The barrel lots, consisting of 20 case (240 bottles), 10 case (120 bottles) or 5 case (60 bottles) per lot, will be sold as described in the catalog.

The producing winery retains sole discretion as to when the wine will be bottled and ready for delivery to the Purchaser. SCV will notify the winning bidder when wine is ready for shipping. The Purchaser acquires only the right to take possession of the wine when notified and has no right of inspection pending notification. The right to take possession shall not be assigned or otherwise transferred without first obtaining the written permission of SCV.

Purchaser agrees to take delivery of the wines within sixty (60) days of notification, provided payment for the lot has been received in full by SCV as required by the Terms and Conditions. Shipping expenses, insurance, and any applicable taxes are the sole responsibility of the Purchaser. Any shipment of the wines out-of-state is the responsibility of the Purchaser, who is solely responsible for compliance with the laws and regulations of said state. SCV's sole liability for failure to tender delivery in California shall be limited to a refund of the purchase price.

Bidders agree that the sales and delivery of Sonoma County Barrel Auction wines shall not affect the rights of the producing wineries to sell their own wines to any distributor of their choosing in bidder's state, or the right of SCV to sell future Sonoma County Barrel Auction wines to any Purchaser in said state. Purchaser agrees to take whatever steps are necessary to accomplish that, including but not limited to the relinquishment of any rights which Purchaser may have under state law.

Indemnity

Participants agree to indemnify, defend and hold harmless Seller and its officers, directors, employees, parents, partners, successors, agents, members, distribution partners, subsidiaries and their related companies from and against any and all claims, liabilities, losses, damages, obligations, costs and expenses (including interest, penalties, and attorney fees and amounts paid in investigation, defending or settling any of the foregoing) arising out of or related to: (i) your purchase, delivery, use or resale of the Wines; (ii) your participation in the Auction; (iii) any actual or alleged violation or breach by you of these Terms & Conditions or of any representation, warranty or covenant that you have made to Seller; (iv) your violation of the law; (v) your negligent or willful misconduct; or (vi) your violation of the rights of any third party. You agree to cooperate fully with us in the defense of any claim that is the subject of your obligations hereunder.

ABOUT THE WINE:

"First & Five" offers a first look at vineyard-to-bottle winemaking at Pride Mountain Vineyards as seen through Winemaker Matt Ward's eyes. Matt joined the winery in July of 2022, making this one of his first priorities. It is also special because it is sourced entirely from the five remaining acres of original estate vines present when the Pride family purchased the property in 1990. The finished wine is 100% Cabernet Sauvignon, vinted entirely from free run juice. South-facing, Rock Arch Vineyard was planted in 1982 at an elevation of 2,100 feet and consistently produces fruit that is included in the winery's portfolio of reserve wines.

Pride Mountain Vineyards is a second-generation family owned and operated vineyard and winery situated at the crest of the Mayacamas Mountains. Since its founding, the Pride family's focus has been on making estate wines that reflect and honor the unique history and mountaintop location of this special property. Rock Arch Vineyard is named for the man-made stone arch that stood over the main entrance to the property in the 1800s. While the arch itself no longer stands, the stone wall that was contiguous to it runs alongside the vineyard that provided the fruit for this lot.

Notes of blackberry tart, cedar, summer savory, currants, bay leaf, and dried orange rind flood the palate, finishing with subtle hints of crème brûlée. While enjoyable in its youth, this wine will richly reward those with the patience to cellar it for a decade or more.

Alexander Valley Vineyards (AVV) and the Wetzel family have a long history with Zinfandel. The culmination of their decades with the varietal was recognized in December 2023 with Wine Spectator's Top 100 list announcement. Alexander Valley Vineyards Zinfandel was the only Zinfandel named to the 2023 list. In celebration of that achievement, they selected one of their most distinctive lots destined for the next vintage of AVV Zinfandel. In honor of the Top 100, AVV is simply calling this wine "Primo."

The southern Alexander Valley is defined by warm days and cool nights. That climate and gnarly old vines planted in 1891 on the valley floor make this a unique and special lot of Zinfandel. The giant head-pruned vines are low-yielding and produce grapes with incredible concentration and flavors.

Winemaker Kevin Hall selected a single barrel of Zinfandel from the century-old vines for this special bottling, allowing the fruit to shine in this small lot. After harvest on Sept 6, 2022, the wine was fermented for three weeks in half-ton macro-bins with gentle punch-downs twice daily to extract flavor and color. After fermentation, the wine was pressed off and settled for 24 hours before being barreled down into a new Barrel Associates American oak barrel. The wine will gently age in AVV's naturally cooled caves for 22 months before bottling. This is a big, rich wine with enticing aromas and the classic spicy flavors that Zin lovers expect, along with beautiful balance and acidity for which Alexander Valley Vineyards is known.

The Battle Family Vineyard, and specifically the singular block that represents this selection, sits high in the eastern, rolling hills of the Chalk Hill area. With a virtually perfect mix of well-draining soils and well-placed sun aspect, it gets intensity and character in a very consistent flavor profile.

The fruit profile of Battle Vineyard exudes the savory fruit from the finer wines of the region. Hints of tobacco and leather combined with lilac fill the nose. Blueberry, blackcurrant and stewed plum are present across the entire palate and are paired with the distinct and abundant tannin from both fruit and barrel.

Known more for pinot noir and chardonnay, the Russian River's cool climate showcases Zinfandel's ability to adapt to the climate where it is planted, offering a nerve of acidity in the wine, while also offering profound depth, nuance, and serious aging potential. This family-owned vineyard continues to be farmed by Joanne Maffei, the fourth-generation farmer of the site.

"Tug O' War Adventure" Zinfandel is deep garnet in color. Pure, lush fruit aromas of brambly berries reflect a classic Russian River profile with the added complexity of floral and candied orange notes. This wine is dark and brooding in nature with a polished, tannic structure filled out with plush fruit and vibrant acidity that leads to a finessed, spicy finish.

BACA is an independent family-owned winery founded by Craig and Kathryn Hall and Directed by Kathryn's daughter, Jennifer Brown. Named for the Latin word for berry, BACA is a journey of wines from Heritage vineyard sites throughout California.

ABOUT THE WINE:

"Block 12" is crafted from a single vineyard block at the famed Farrow Ranch, Aperture's eastern hillside Geyserville estate vineyard site. This is the first 100-point vineyard in Alexander Valley history. While the Aperture team works with several of the distinctive block gems on the 80-acre property, this particular block has never been highlighted on its own before.

The team at Aperture first began working with Farrow Ranch for the 2010 vintage and created its first single vineyard wine for the Devil Proof Vineyards Malbec, their sister label in 2012. After having the privilege of working with the property for a decade and multiple 100-point scores were achieved from the vineyards, Aperture purchased the property to ensure future work with all the vineyard blocks, including the exceptional Cabernet Sauvignon vines from block 12. "Now that we have ownership of the estate," said founder and head winemaker Jesse Katz, "we have access to blocks we never had access to before." These vines grow on red iron-rich volcanic soil and the wine will be matured for 22 months in 100% new French oak.

"Block 12" demonstrates a full-bodied palate with concentrated fruit, supported by velvety tannins and a seamless, underlying vein of freshness that drives the wine. Expect this wine to gain intensity and nuance as it spends time in the glass and will be long-lived in the cellar.

ABOUT THE WINE:

Mark McWilliams of Arista Winery approached his friend Rod Berglund of Joseph Swan Vineyards and explained that the Pinot Noir wines produced by their respective vineyards have never been made by anyone than their two estate wineries. Arista did not make a Pinot Noir from the Laguna Ridge neighborhood and Joseph Swan did not make one from the Middle Reach Neighborhood. What if the two wineries swapped a small amount of fruit? Expecting instant rejection, Mark was shocked with Rod's tentative "yes." They walked each other's vineyards and the deal was done.

Arista Two Bird's Vineyard is named after the founders (Mark's parents) nickname. The Joseph Swan Trenton Estate Vineyard is named after the former community of Trenton where the winery and vineyard are located. The house was also the town's post office and general store. The first Pinot Noir was planted by Joseph Swan in 1969 to what became known as the Swan Clone of Pinot Noir.

This unique lot is the first (and only) time Mark McWilliams and Rod Berglund have combined not only each of their own respective Estate Vineyard lots but also the wines they have made from each other's estates. However, they needed a name for the project and "Three Birds Squared" was born. A swan, from the name Joseph Swan, is one real type of bird and Arista's vineyard is named Two Birds! ABOUT THE WINE:

This delicious Bordeaux blend was crafted by winemaker Julien Fayard and blended from the best barrels of the small lot wines produced by Brandon Gregory Estate in 2022. In 1871, Clark Foss, a daredevil stagecoach driver and entrepreneur, founded the town of Fossville which once stood on the land of Brandon Gregory Estate's Brookshire Vineyard. Foss started a stagecoach line to service luxury tourists traveling from Calistoga and Healdsburg to the geysers on Mount Saint Helena. Foss became a star, earning the reputation as an entertainer who coaxed his horses to go too fast on the winding road. Passengers were both thrilled and frightened by the experience. Prominent visitors included JP Morgan, William Randolph Hearst, President Ulysses S. Grant, and Mark Twain. "The Journey" was named to honor the many journeys of Foss and the estate's journey in winemaking.

Over the past decade, vintners Brandon Muller and Gregory Roberts acquired two Knights Valley properties, Helena Vista Ranch and Vineyard, and Brookshire Ranch and Vineyard, totaling 1,186 acres. Sixty-two acres of premium grapes are planted, and the remainder is reserved as pristine conservation land.

Grapes are harvested by hand in the early morning and then optically sorted at the winery to ensure only the best berries are selected. Wines are fermented on skins as separate lots, transferred to French oak barrels, and aged before blending. Blended wines are returned to barrel for additional aging before bottling. This wine will be bottled without fining or filtration. Expect intertwined aromas and flavors of classic Cabernet Sauvignon and Cabernet Franc markers, including blackberry, cherry, cassis, and dried crushed herbs with approachable tannins, silky texture, lively acidity, and a fresh and long finish.

ABOUT THE WINE:

"Ash and Wind" is made of grapes from the very first harvest of the newly planted Sweet Family Vineyard. Developed and farmed by Charlie Chenoweth, this protected bowl sits at 750 feet of elevation on the southern side of Sonoma Mountain. Brooks Note was very lucky to run experimental lots on nearly all of the clones planted at the site and put together this unique blend. They regard the 2023 growing season as a once-in-a-career vintage that allowed for the ideal ripening pattern.

The lot name references two of the unique characteristics, wind and ash, that shape the wines produced from this site. Vineyards in the Petaluma Gap are significantly affected by the winds that lengthen the growing season and thicken grape skins, which help make flavorful wines with great structure. Ash is a reference to the prolific rhyolite deposits throughout the vineyard which are from ancient Sonoma Volcanics. This volcanic stone has limited nitrogen content, but is rich in micronutrients which naturally limit the vines vegetative growth and increase access to beneficial micronutrients. Rhyolitic soils are also known to help plants uptake and sequester more carbon from the atmosphere!

Owner-operators Garry Brooks and Joanne (Note) Brooks, founded their small family winery, Brooks Note, in 2012. What started as a Pinot Noir passion project has turned into a community of intrepid wine fans. Anchored in downtown Petaluma, Brooks Note presents a portfolio of elegant, vineyard-driven wines from the hidden corners of Sonoma, Marin and Napa, made by Garry himself. "Wind and Ash" has beautiful purity of fruit, with subtle floral and spice aromatics that enhance the bright red fruit flavors. The wine finishes with a lovely crispness and pronounced minerality.

The true essence of Chalk Hill is its estate, a unique corner of Sonoma County wine country. Here, proprietor Bill Foley both preserves the nature of the land and honors it by producing wines reflecting its exceptional qualities. All grape-picking decisions are based off taste, with late or extended hang time added to minimize any pyrazines and soften tannins. The winemaking team keeps each vineyard pick separate, ferments and ages them separately, then blends at just the right time to allow the wines to marry together.

"Winner's Circle" is fruit-forward with aromas of Bing cherry, cranberry and spice. The palette offers earthy undertones with hints of mushroom and tobacco. Soft chewy tannins provide a layered structure with complexity and depth.

This attention to detail during the growing season leads to a hands-off approach in the cellar. Pressed and sent to barrel after 48 hours of settling, this wine undergoes a long, cool fermentation on ambient yeasts and naturally occurring full malolactic conversion. Bottled unfined and unfiltered after an 18 month élevage, expect flavors of green pear, lemon curd, mint, white pepper, crushed rocks and slate.

"Untamed" is cool-climate Pinot Noir in one of its rarest forms: crafted from two small blocks of the Hyde clone at the Emeritus estate Hallberg Ranch Vineyard that yield only a few tons each harvest. Never before bottled on their own, these two blocks were picked, fermented, and aged as a separate lot. The result is stunning - a wine that showcases this historic clone at Hallberg Ranch, yet still maintains the charming and elegant style ubiquitous to Emeritus.

The Hyde clone came to Emeritus while legendary vintner Brice Cutrer Jones and Aubert de Villaine, proprietor of Domaine de la Romanée Conti, were developing a vineyard together on the coastline of Sonoma County. Brice asked Aubert for the finest clone of Pinot Noir he knew of, and Aubert said that his cousin-in-law Larry Hyde had one, which vineyard manager Kirk Lokka promptly went to pick up. Several years after, Aubert inspired Brice to dry-farm his vineyards, a decision that would forever alter the style of Emeritus. The winery is celebrating its 25th anniversary this year. Now second-generation vintner Mari Jones leads the charge as winery president, joined by a talented team who share Brice's exacting vision for quality and are the true backbone of this family-run winery.

"Untamed" was 15% whole-cluster fermented, encouraging complexity and soft tannins that help complement the rustic nature of the Hyde clone. Emeritus's barrel program has lighter toasting and uses predominantly Vosges wood, contributing to a Pinot Noir that is built to age beautifully, expressive now with the capacity to develop over the next ten years. The wine is an authentic, distinctive, individual Pinot Noir, reflecting the earthiness of the Hyde clone and the red fruit of Russian River Valley. It's concentrated, complex, and characterful.

ABOUT THE WINE:

Ferrari-Carano has never created a blend of the three Cabernet Sauvignon blocks that are selected for their PreVail Wines - West Face, Lookout Tree, and Back Forty. "PreVail Trio" is the first wine to represent all three wines in one bottling. These are all hillside vineyard blocks ranging in elevation from 500 to 1200 feet.

Don and Rhonda Carano, natives of Reno, Nevada, and second generation Italian-Americans, founded Ferrari-Carano in 1981. The first wines released were a 1986 Fumé Blanc and a 1985 Alexander Valley Chardonnay. Owned by Bill and Carol Foley since 2020, Ferrari-Carano still produces Fumé Blanc and Chardonnay as well as over 20 other white and red wines. Ferrari-Carano's 21 vineyards and winery have earned California Sustainable Winegrowing Alliance (CSWA) certification, becoming a Certified California Sustainable Vineyard for their numerous efforts to preserve the land for future generations while producing memorable, sustainable wines of outstanding quality.

The grapes for "PreVail Trio" were destemmed and berry sorted through an optical sorter, then transferred to stainless steel tanks for five days of cold soaking. Then yeast was added and pump-overs commenced, one to two times daily, for the duration of primary fermentation. The wine was then drained to French oak barrels for malolactic fermentation and cave aging before bottling. Expect flavors of ripe, dried currants, thyme, leather, graham cracker, and spiced plums with plush, velvety tannins and a long finish.

ABOUT THE WINE:

Marimar Estate has been growing and making Tempranillo for 15 years, but this is the first barrel selection from their finest lots to make a special small bottling. The lot name "TEMP'rature Rising" is a play on words with Tempranillo and rising temperatures in wine growing regions. As a company, Marimar Estate strives to do their part to battle climate change. Tempranillo vines are able to cope with rising temperatures, sunburning, and drought conditions, making this variety adaptable for the future.

Marimar Torres is the 2024 Sonoma County Barrel Auction Icon, an honor that recognizes individuals who have had a significant impact on the evolution, development and perpetuation of Sonoma County wine and have helped raise the global perception for the region. The Torres family has been dedicated to wine for five generations. They began producing wine in Penedès in 1870, although their winegrowing roots date back to the 16th century. Originally from Spain, Marimar Torres grew up as a fourth-generation member of the family and moved to San Francisco in 1975. After two years of searching, she acquired land in the Russian River Valley in 1982 and began planting the Don Miguel Vineyard in 1986. A Catalan farmhouse-style winery was built in 1992. Marimar's daughter, Cristina, now works alongside her as General Manager and joined the leadership at Marimar Estate in 2020. This will be the first time in the Torres family that the business will be passed from mother to daughter!

This wine has fantastic balance between fruit and structure, which is the style of wine Marimar aims to make. It is elegant and powerful at the same time. It features aromatics of darker fruit notes, dry leaves, and leather. There is a balance between earth and fruit, fruity and fleshy, while also having very complex spicy and savory flavors. This is a wildly diverse, food-pairing wine.

ABOUT THE WINE:

"Downeast Old Wente" is a block-designated wine from Eastside Estate Vineyard. The grapes from this mono-clone block are hand-picked, pressed and fermented independently to distinguish its unique characteristics from the rest. Winemaker William Weese believes this vintage represents one of the best from the Russian River Valley. The term 'Downeast' is traced back to the nautical culture of New England where sailors used the southwestern prevailing winds to sail downwind to the east. Today this term has expanded to refer to much of the Maine coastline and the people who reside there. Peter Merriam, a native of Maine and avid fly fisherman, enjoys spending time along the coast in the summer months fishing for striped bass. "Downeast Old Wente" is Merriam Vineyards' journey toward the coast, down the Russian River along Eastside Road.

Merriam Vineyards was founded in 2000 by Peter and Diana Merriam. The first wine produced came from a 12-acre vineyard on Limerick Lane that they named Windacre Vineyard after their home in Maine. Today, Merriam Vineyards farms 45 acres across three vineyard sites in the Russian River Valley, producing Bordeaux and Burgundian-style wines.

"Downeast Old Wente" was hand-picked in the early morning and fermentation began with a method known as 'pied de cuve.' This distinctive wine was fermented and aged in 100% new Alain Fouquet Montrachet barrels. The soft tannins and tight grain of the French Oak complement the expressive characteristics of Old Wente clone Chardonnay to beautifully accentuate the terroir of this unique block. This 2023 Chardonnay shows notes of apple, pear, caramel, nutmeg and cinnamon spice.

"Three Ridgelines" is a rare trade release of Flowers Pinot Noir sourced from Fort Ross-Seaview, comprised of organically farmed fruit from their iconic Sea View Ridge estate (planted in 1998) as well as lots from multi-generational family growers with whom they have longstanding partnerships. The Fort Ross-Seaview AVA is defined by vineyards dotting the first three ridgelines edging the Pacific Ocean on the far reaches of the Sonoma Coast. ABOUT THE WINE:

"Eminence" reflects the elevated status and distinguished legacy of the Archimedes Vineyard, where the grapes for this wine are sourced from a single block. The name signifies the position of the vineyard, situated at the highest elevation vineyard in Sonoma County, ranging from 2,300 to 2,600 feet above sea level. The connection to Archimedes, the legendary mathematician and inventor, adds a layer of intellectual and historical significance to the name. Like Archimedes, who developed the heat ray to harness the power of the sun, "Eminence" embodies a similar mastery and innovation in winemaking, capturing the essence of being at the pinnacle of quality, and paying homage to the meticulous care and attention put into crafting this unique lot.

In April 2017, the Coppola family purchased a 100-acre parcel in the Pine Mountain-Cloverdale Peak American Viticultural Area which included the Silverwood Vineyard. This ultrapremium Cabernet Sauvignon and Malbec producing vineyard contributes to Coppola's highly-acclaimed flagship wine, Archimedes. The Coppolas purchased the property from Silverwood Ranch owners Barry and Jackie Hoffner, pioneers of the distinguished AVA and instrumental growers in the Coppola portfolio for years. A pivotal vineyard to the Archimedes wine, it only made sense to rename the Silverwood Vineyard to Archimedes Vineyard.

"Eminence" was aged for 18+ months in oak to develop a round and sultry expression of the tannins. Dark fruit aromatics with warm cocoa and toasted hazelnuts fill the nose. On the palate the wine shows blackberry bramble, marionberry and dark cherry followed with a toasty, crushed velvet finish.

ABOUT THE WINE:

The wine is from a single block of Laurel Glen's organically farmed estate vineyard named Block 1. The winery has never bottled wines from individual blocks, and so this is truly a "Never Before, Never Again" selection. Block 1 was the first Cabernet Sauvignon ever planted at Laurel Glen Vineyard in 1968. Previous owner Patrick Campbell always considered it his best block. When Bettina Sichel and her partners bought Laurel Glen Vineyard in 2011, Block 1 was not in good shape. They pulled out the block in 2012, left the ground fallow for two years and replanted in 2014 with different spacing, row direction and trellising. Block 1 is now fully back in production and yielding excellent quality fruit. Its back, baby, and better than before!

Laurel Glen Vineyard is 1,000 feet up the slope of Sonoma Mountain, a much cooler location for Cabernet Sauvignon than most. It produces wine somewhere between California and Bordeaux in terms of acidity, ripeness, and balance. Phil Coturri has farmed the vineyard since 2011. Winemaker Randal Watkins has been crafting powerful yet elegant mountain Cabernet Sauvignon for over 25 years.

Block 1, the source of this wine, was the only vineyard block from 2022 fermented with 25% whole clusters, adding an additional layer of fruit and spice to the finished wine. The strikingly seductive, expressive bouquet of "What's Old is New Again" offers kirsch, blackcurrant, raspberry and fresh floral scents. It's suave and silky, with deep but energetic red and dark fruit flavors, baking spices and a terrific mineral lift.

The exquisite wine produced was a standout and begged to be given the spotlight, so "New Kid on the River Block" was born. The resulting wine exudes vibrancy, freshness, and a solid core of dark fruit that is buoyed by the earthy richness and structural depth of more mature Old River Block vines, highlighting a true Pinot Noir gem from unique circumstances in a surprising vintage.

The 2023 vintage marked 41 years of the amazing partnership between Gary Farrell Winery and Rochioli Vineyards & Winery. ABOUT THE WINE:

The "1868" barrel auction lot pays homage to the Mauritson family history in the Rockpile region, as the family has farmed this property contiguously since they homesteaded it in 1868. Mauritson Wines has never before bottled a Cabernet Sauvignon from the Campground block in their Rockpile Ridge Vineyard. This micro block is planted to a heritage clone of Cabernet Sauvignon, often referred to as the See's clone. This clone thrives in the shallow, rocky soils that define the Rockpile appellation, producing standalone Cabernets that have incredible depth and detail.

Rockpile is a unique American Viticultural Area (AVA) in Sonoma County. It is one of the only AVAs to have an elevation requirement (800ft and over), it is surrounded by water on three sides (Lake Sonoma), it only has (approximately) 225 acres of vineyards. It has a very moderate climate due to the presence of Lake Sonoma and the proximity to the coast, it has a much smaller diurnal shift than some other growing regions, and it does not have any fog during the growing season due to the inversion layer created by the lake.

The Campground vineyard is planted right over the top of an active earthquake fault. There is little to no topsoil, resulting in very little water retention. The lack of water combined with the unique clonal selection create extremely small berries. The resulting wines are ultra concentrated and have incredible structure. This micro block was fermented separately, contributing to "1868" becoming a big, rich wine that will age with incredible grace.

Just a few miles south as the bird flies, or about a 30 minute drive down the mountain and Highway 12, Glen Oaks Vineyard is another west facing hillside along the bench of the Mayacamas. This warmer pocket of Sonoma Valley produces wines that are rich, dense and mouth filling.

Nottingham Cellars was established in 2009 and started producing single vineyard Cabernet Franc in 2012. By 2021 they had built a new production facility and completely migrated their business and families to be closer to vineyard sources. They are committed to the growth and success of Sonoma County and are thrilled to be part of the community.

This is classic Cabernet Franc with perfumed red and blue fruits, violets and a trace of herbal undertones. "Embrace the Franc" is a rich, well-structured wine that will drink great in its youth but has the tools to age gracefully.

ABOUT THE WINE:

"Terraces Above the Fog" is made from the Winemaker Jeff Pisoni's favorite barrel of wine from his favorite vineyard block, planted 100% to Calera Clone Pinot Noir. This block, called the Terraces, wraps around the mountainside and produces elegant, complex wines every vintage. Owner Lester Schwartz thought that he could carve the Terraces out of the hillside himself but soon realized it was far too treacherous and brought in a professional. He and Linda were tireless in the creation of Fort Ross Vineyard and did much of the work themselves.

Inspired by the majesty of the wild Sonoma Coast, owners Linda and Lester Schwartz founded Fort Ross Vineyard in 1994 when they began preparing grassland at the top of the steep, rugged coastal ridge to plant to grape vines. The picturesque, 52-acre single vineyard is a necklace of 32 small mountain blocks that range in elevation from 1,200 to 1,700 feet overlooking the Pacific Ocean which lies just a mile to the west. Linda and Lester strive to masterfully craft profound wines of purity and elegance that reflect the challenges of this extreme site and the cool maritime climate.

Fort Ross Vineyard's production is limited to 5,000 cases annually as they only use their family estate grown Chardonnay, Pinot Noir and Pinotage grapes. The fruit that flourishes in this rugged atmosphere resulting in unforgettable wines. "Terraces Above the Fog" is a pure expression of a single clone, in which expansive aromatics of red currant, raspberry, black tea and violets unfold with complexity. The fruit-driven palate reveals a graceful core of ripe cherry, black currant, wild berry and just a touch of tart juicy plum followed by a persistent lush finish. With its lively acidity and balanced structure, this charming Pinot Noir is going to be a beauty.

When these two vineyards are blended, it creates a wine with tremendous depth and layers of flavor, showcasing the unique attributes of both historic sites.

Lytton Springs is home to 100-plus-year-old Zinfandel vines and a prime example of Ridge's commitment to championing heritage varietals, meaning grape varieties planted more than a century ago and surviving in numerous locations. The wine is named for the daughter of the original family who planted the Pinot Noir in River Road Vineyard. This estate vineyard was planted 24 years ago, and is still managed by the same vineyard manager who also planted the vines, Alvaro Zamora.

Located in the coolest appellation in Sonoma County, the Green Valley of the Russian River Valley, the vineyard sits on 100% Goldridge Soil, which promotes stress on the vines, leading to concentrated flavors in the berries.

Winemaker Ed Morris takes a unique approach, based on his experience having a coopering background, as he chooses the relationship between the oak and wine. Expect flavors of cherry and raspberry, with hints of an earthiness and spice, which adds to the complexity of the wine. The vineyard's cooler climate preserves the natural acidity of the grapes, which delivers a well-balanced and elegant Pinot Noir.

The collaborative barrel auction lot "Heirloom" from Rochioli Vineyards and Winery, Bacigalupi Vineyards and Ramey Wine Cellars is the first collaboration of Pinot Noir with these legendary families, a rare creation that will never be replicated. With over a century of grape growing and wine making experience and generational knowledge, these winemaking teams have created a wine blended from exceptional Russian River Vineyards, all estate owned by their families. "Heirloom" represents something that holds sentimental and historical value, connecting generations and preserving family heritage.

All three wineries - Bacigalupi, Rochioli and Ramey - are a distinguished group of pioneering American vintners who revolutionized modern-day winemaking and elevated Californiatotheforefrontoftheinternational winecommunity. Joe Rochioli helped Charles and Helen Bacigalupi bud over their first vineyards in 1964 to Chardonnay and Pinot Noir. David Ramey made wine from the Bacigalupi Chardonnay at Rudd Winery in the late 1990s when he was winemaker there and worked closely with Helen and Charles Bacigalupi when purchasing fruit. These winery families have a deep commitment to keeping their multi-generational businesses running and maintaining their excellent reputations in the industry.

ABOUT THE WINE:

Located in the heart of the famed Russian River Valley, often proclaimed ground zero for great Pinot Noir, Joseph Swan Vineyards embraces the artisanal spirit that defines this amazing growing region. For this unforgettable lot, Winemaker Rod Berglund combined fruit from two vineyards only a short distance apart. Same grape, same clone, same tight spacing, same farming, same winemaker... yet light years apart in character. One is deep, wild and gamey like the wines of Cornas in the northern Rhône, the other resembles Côte Rôtie.

The difference must be the soil. One is on fractured rocks from the Franciscan Melange, deposited some 80-100 million years ago. The other is planted on fine grained sandy Goldridge that the Wilson Grove Sea left behind about three to five million years ago. Both vineyards have always been bottled separately but in this wine, rocks meet sand in a beautiful, unique blend for the first time ever.

ABOUT THE WINE:

"Knights Delight" highlights fruit for this very special barrel lot coming from the Knights Valley American Viticultural Area. The 2022 vintage in Sonoma County was superb for Bordeaux varietals. After early summer heatwaves that led to strong canopy development, they enjoyed consistent, dry weather with perfect 85-90 degree temperatures throughout the fruit maturation period. These two low yielding vineyards provide limited, highly allocated grapes each year. The ideal growing conditions of the 2022 vintage provided just a little extra bounty to give their winemaker some room to play. While still within the bounds of a classic Cabernet Sauvignon dominant Bordeaux-style blend, this wine results from a slightly atypical choice of sites and minimalist blending philosophy - marrying the beauty (cool climate Cooley Ranch Malbec) with the beast (warm climate Bavarian Lion Vineyard Cabernet Sauvignon).

This is both a vintner's wine, emphasizing the art of the blend, and a vigneron's wine, offering an expression of two distinctly different terroirs within Sonoma County. Optical sorting of the grapes upon receival ensures purity of fruit character, and extended thermal maceration caramelizes the tannins for a well-structured yet velvety soft mouthfeel.

Expect cassis with briary blackberry and blue fruit, supported by complex undertones of sassafras, cherry cola, and rich milk chocolate. Subtle vanilla and baking spice notes with fine grained tannins derive from aging in new French Oak barrels. The wine has ample structure for aging 10-15 years, but the juicy, plush Malbec component brings youthful approachability, particularly with a recommended one or two hour decant.

ABOUT THE WINE:

The Sangiacomo family has farmed the Carneros region for generations. The fruit for "Home Ranch" comes from Home 82, the oldest block at the Sangiacomo family's original homestead located on the Sonoma County side of the cool, windy Carneros region. This single vineyard designate showcases the distinct character of the vineyard. Planted in 1982, these old vines have small yields of exceptionally dense grapes.

"Home Ranch" was whole-cluster pressed and cold settled overnight. The wine was then racked into 500L French oak puncheons for primary and secondary fermentation. Stirring, or bâtonnage, of the barrels occurred weekly for a creamy, plush texture. This special wine was then aged in a single, new 300-liter cigar French oak barrel.

Expect ripe yellow peach and pie crust intertwining with honeysuckle on the nose and palate which, blend seamlessly with subtle oak. An exceptionally rich mid palate gives way to a long finish with more candied flavors, spiciness and richness of oak.

ABOUT THE WINE:

Let's get down to the "bare" facts... Desnudo Vineyard (which translates to 'nude' in Spanish) is located on the southern end of the Mayacamas Mountains, and in the 1940s it was a nudist colony known as Sun-o-ma. The nudist ranch, in its heyday, drew hundreds of visitors to the remote ranch accessible only through a road on the Bartholomew Park estate. The compound once had cabins, a swimming pool, saloon and general store where 'au natural' visitors would gather to enjoy the sweet Sonoma Valley sunshine. The original vineyard was planted in the early 1990s under the direction of Gundlach Bundschu Winery. This lot was named "Nude on the Left Bank" since it is a blend of Cabernet Sauvignon and Merlot from Desnudo Vineyard and made in a style reminiscent of the wines of the Médoc in the Left Bank wine region of Bordeaux.

Sojourn produces its Cabernet Sauvignon wines in a Burgundian style, meaning fermenting in open top tanks, minimal nutrients, lower temperatures, with gentle punch downs and just a few pump overs. The resulting Sojourn wines are nuanced and elegant, with layers of flavors and texture. For this blend, Winemakers Randy Bennett and Eric Bradley focused on showcasing the expressive red fruit flavors of the Merlot with the darker fruit, herbal notes, and earthiness of the two distinctive mountain Cabernet Sauvignon blocks.

"Nude on the Left Bank" is medium red to garnet in color. Aromas of black cherry and currant explode from the glass, followed by notes of vanilla, dry herbs, tobacco leaf and toasty oak. On the palate it is medium to full bodied with a smooth mouthfeel and a lively, savory edge. It is incredibly well balanced with its silky tannins and acidity.

ABOUT THE WINE:

WALT Estate Vineyard, Bob's Ranch, lies alongside the region known as the Petaluma Wind Gap. This area is known for cooler temperatures due to the connection of fog and wind funneling along a pathway from the Pacific Ocean through the Bodega Bay and to the San Francisco Bay. Bob's Ranch Estate is defined by diverse aspects along gently rolling hills and is planted with seventeen distinct clones and heritage selections of Pinot Noir.

To produce the 2023 Bob's Ranch "1,000 Miles of Pinot", the winemakers began their work in the vineyard, carefully selecting individual blocks of fruit that highlight an expressive, powerful style of Pinot Noir. Typically, the clusters in these blocks showcase millerandage, where tiny berries form alongside larger berries. The small berries provide purity of flavor and concentration, while the large berries in the clusters form the finesse of freshness and acidity. Additional vinification of whole cluster, in both stainless steel and concrete tanks, enhances these characteristics. The result is a concentrated and focused Pinot Noir with profound fruit, savory texture, and vivid structure which will offer pleasure on release while also allowing for careful cellaring for years to come.

WALT is an independent family-owned winery founded by Craig Hall and Kathryn Walt Hall. 
